Fair Competition Code in Korea

Purpose

- · Ensure public order of fair competition in the distribution of Medical Devices
- · Maintain and improve public health by curbing unfair customer solicitation

Relevant Law

· Fair Trade Act

Prohibition of Unfair Trading(Unfair Solicitation of Customers)

· Medical Devices Act

Dual Punishment Provision(7 safe harbors for provision of economic profit)

Process

 up to KRW 200,000(USD 170)/night (Domestic); up to KRW 350,000(USD 280) / night(Overseas) (VAT incl.)

Souvenirs, Promotional Gifts



- **Souvenirs :**within KRW 50,000(USD 43)
 (multiple medical institutions)
- Promotional gifts:
 within KRW 10,000(USD 8.5)


